SUBJECT: Application for Certificate of Appropriateness

BACKGROUND

Philip Connolly and Heidi Beckstrom are proposing to paint their house and carriage house and replace the roof on both dwellings at 111 South Dakota Avenue. They will present the colors at the meeting. The painting and roof replacement are changes consistent with the Historic Preservation Guidelines since they will not adversely affect or not harmonize with the external appearance of other neighboring improvements on such site or within the district provided the colors presented are consistent with historic guidelines.
